- **IN-TOWN/RESIDENT IS DEFINED AS ANY PERSON OR FAMILY WITHIN A TEN-MILE RADIUS OF HILLCREST GOLF & COUNTRY CLUB.**
  - **ALL LEVEL 1-5 MEMBERS THAT ARE MARRIED OR HAVE CHILDREN MUST PAY FAMILY RATE. AGE AS OF JANUARY 1<sup>ST</sup> OF THE CURRENT YEAR OF THE OLDEST SPOUSE DETERMINES THE GOLF MEMBERSHIP LEVEL.**
  - **ALL GOLFING MEMBERSHIPS OVER THE AGE OF 35 ARE REQUIRED TO PURCHASE STOCK VALUED AT \$500. YOU MAY MAKE PAYMENT IN INCREMENTS OF \$250 OVER TWO YEARS.**
  - **FOR LEVELS 1-5: THOSE LIVING 11 TO 20 MILES OUTSIDE THE RADIUS OF HILLCREST ARE ELIGIBLE FOR A 30% REDUCTION OF GOLF DUES. THOSE OUTSIDE THE 20 MILE RADIUS ARE ELIGIBLE FOR 50% GOLF DUES REDUCTION.**
  - **THERE IS A \$50 DINING AND LOUNGE MINIMUM PER MONTH FOR FAMILY MEMBERS, \$35 PER MONTH FOR SINGLE MEMBERS (USE IT OR LOSE IT) FOR THE MONTHS OF APRIL THRU OCTOBER. BEGINNING NOVEMBER OF 2011, THERE WILL BE A \$25 DINING AND LOUNGE MINIMUM PER MONTH FOR FAMILY MEMBERS, \$17 PER MONTH FOR SINGLE MEMBERS FOR THE MONTHS OF NOVEMBER-MARCH. THIS IS BILLED ON A MONTHLY BASIS WITH ONE EXCEPTION. APRIL & MAY'S MINIMUMS ARE COMBINED - YOU MUST SPEND \$100(FAMILY) OR \$70(SINGLE) BY THE END OF MAY. ONLY HILLCREST CHARGE TICKETS POSTED TO YOUR ACCOUNT DETERMINE THE AMOUNT SPENT. CASH SALES, BEVERAGE CART SALES, TIPS, TAXES AND OTHER MEMBER FEES DO NOT QUALIFY. MINIMUMS ARE TAXABLE.**
  - **THERE IS A ONCE PER YEAR \$50 CHARGE FOR PRO SHOP CREDIT FOR ALL LEVELS 1-5 AND PARTNERSHIP MEMBERS. IT WILL APPEAR ON YOUR FIRST BILLING AND IS REDEEMABLE FOR MERCHANDISE IN THE PRO SHOP THROUGH OCTOBER 31, 2010.**
  - **ALL ACCOUNT BALANCES ARE DUE WITHIN 30 DAYS FROM THE DATE OF YOUR STATEMENT. A \$20 LATE FEE/FINANCE CHARGES WILL BE ASSESSED MONTHLY FOR ALL PAST DUE ACCOUNTS**
